

Call for Papers

[The Child Rights and Justice Journal]

The Child Rights and Justice Journal (CRJJ) is a national journal sponsored by UNICEF-Nepal in cooperation with Secretariat of Central Child Justice Committee. The CRJJ focuses on broad range of legal as well as psychological issues confronting children, including child welfare, juvenile justice, mental health, child victims and witness, best interest and well-being of the children etc. The major goal of the journal is to provide a resource materials on the issue of child rights and justice to the practitioners/advocates in law, psychology and related field.

Who can submit

Academicians, Research Scholars, Law Professionals, Law Students and others who are interested in the field of child rights and justice can submit original manuscripts of articles, case notes and legislative comments relating to a recent development in the child rights and justice sector.

Type of Contribution Accepted

The CRJJ invites original, unpublished manuscripts from all academicians, research scholars, law professionals, law students and anyone having an interest in the field of child rights and justice in the following categories:

- **Articles** – The article must analyze and offer new perspectives and provide critical insights to the current practice in the field, trace out the problems and weaknesses in law and practice and offer constructive suggestions and a way forward. Word limits being 6000 to 10000 words excluding footnotes.
- **Notes and Comments** – It is used for analysis of any contemporary judicial pronouncement, legislative action or policy proposal. It must trace the line of cases in which the decision appears and comment on its implication on the given subject or issue. Likewise, the legislative comment or policy proposal must identify the object and expected impact of the legislative action or policy proposal in question. Word limits being 3500 to 6000 excluding footnotes.

Submission Guidelines

1. Citation Format: the citation format to be followed is The Bluebook (20th Ed.) or any standard format.
2. Abstract: Every submission must be accompanied by an abstract of 200-300 words highlighting the relevant conclusions drawn in the manuscript.
3. Biographical Information of the Authors: Details biographical information of the authors including name, surname, designation, name of institution/college (if applicable), year (if applicable), academic year (if applicable).
4. Paper with plagiarism less than 25% are only eligible for publication.
5. Scripts – the paper could be submitted in either English or Nepali script.

6. Font/format Style – 1.5 line spacing, footnote (Font size 10) for English: Times New Roman, Headings (Font size 14), Body Part (Font size 12), for Nepali: Unicode (Kalimati), Headings (Font size 16), Body Part (Font size 14), footnote (Font size 10).

Deadline

The paper must be submitted before 31st May, 2022.

Note

It is the sole discretion of the Secretariat of the Central Child Justice Committee to accept or reject the articles or papers. Upon submission, the selected manuscript shall be the property of SCCJC. Henceforth, articles/papers accepted for publication may be cross-published or republished. Such cross-publishing or republishing shall not require the prior consent of the author(s).
